The mailing address and street address of the principal office of the Company is 6701 North Hiatus Road, Ft. Lauderdale, Florida 33321.

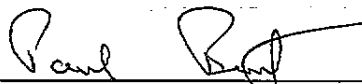
ARTICLE III - Registered Agent and Office
