The undersigned, desiring to form a limited liability company under the provisions of Florida Statute 608, as amended, hereby sets forth the following:

**ARTICLE I**

**Name**

The name of the Limited Liability Company is **ACUITY SOLUTIONS, LLC.** (hereinafter referred to as the "Limited Liability Company")

**ARTICLE II**

**Principal Office & Mailing Address**


