The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be **CURVENTION, LLC** ("Company").

**ARTICLE II - ADDRESS**

**ARTICLE III - DURATION**


**ARTICLE IV - REGISTERED OFFICE AND AGENT**
