ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

The undersigned, for the purpose of amending the Articles of Organization of TWOSOME FLEX ASSOCIATES, L.L.C., a Florida limited liability company, hereby makes, acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 608.411, Florida Statutes.

TWOSOME FLEX ASSOCIATES, L.L.C.

FIRST: The Articles of Organization of TWOSOME FLEX ASSOCIATES, L.L.C., were filed with the Florida Department of State on June 21, 2002, and were assigned Document Number L02000015624.
