**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF  
TWOSOME FLEX ASSOCIATES, L.L.C.**

The undersigned, for the purpose of amending the Articles of Organization of TWOSOME FLEX ASSOCIATES, L.L.C., a Florida limited liability company, hereby makes, acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 608.411, Florida Statutes.

**FIRST:** The Articles of Organization of TWOSOME FLEX ASSOCIATES, L.L.C., were filed with the Florida Department of State on June 21, 2002, and were assigned Document Number L02000015624.

**SECOND:** The following amendment to the Articles of Organization was adopted by TWOSOME FLEX ASSOCIATES, L.L.C.:

Article VIII of the Articles of Organization is hereby amended by deleting the existing Article VIII in its entirety and replacing it with the following:

**ARTICLE VIII -- MANAGEMENT**

The Company shall be managed by a Manager, Joanne H. McGarvey, in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization.
