ARTICLES OF ORGANIZATION OF

InvestGroup II Development , L.L.

ARTICLE I

The name of this Limited Liability Company shall be InvestGroup II Development, L.L.C.

ARTICLE II PURPOSE

This limited liability company is formed for the purpose of transacting any and all lawful business for which limited liability companies may become organized in the State of Florida.

ARTICLE III DURATION

This limited liability company shall commence business on the day of the acceptance of these Articles of Organization and shall exist for twenty five years from the date of acceptance of these Articles of Organization. This period may be extended from time to time, by amendment to these Articles, upon the unanimous vote by the members.
