## ARTICLES OF ORGANIZATION OF ROSEN SWITKES LEVINSON P.L.

The undersigned Member hereby makes, subscribes, and files these Articles of Organization for the purpose of forming a professional limited liability company under the Professional Service Corporation and Limited Liability Company Act:

1. Name. The name of the professional limited liability company is Rosen Switkes Levinson P.L., which is being formed for the practice of law.
2. Duration. The period of duration of the professional limited liability company is perpetual.
3. Principal Office. The mailing address and the street address of the principal office of the professional limited liability company is 407 Lincoln Road, Penthouse Southeast, Miami Beach, Florida 33139.
4. Registered Agent and Office. The name and address of its initial registered agent in the State of Florida, whose Consent to Appointment as Registered Agent accompanies these Articles of Organization, is Robert Switkes, 407 Lincoln Road, Penthouse Southeast, Miami Beach, Florida 33139.
5. Admission of Additional Members. Additional Members will be admitted only upon such terms as are unanimously agreed to by all the voting Members of the professional limited liability company.
6. Regulations. The professional limited liability company shall adopt Regulations for its governance. All matters, other than as set forth in these articles of organization including those relative to the right of the voting and nonvoting members of the professional limited liability company shall be determined by the Regulations. The power to adopt, amend or repeal the Regulations shall be vested in the voting members of the professional limited liability company.
7. Continuity; No Right to Distribution on Withdrawal. The remaining Members of the professional limited liability company will have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other event, which terminates the continued membership of a Member in this professional limited liability company. No Member shall be entitled to receive a return of capital or other distribution upon withdrawal from this professional limited liability company or otherwise, except as otherwise provided in the Regulations of this professional limited liability company.
8. Management. The business of the professional limited liability company shall be conducted under the unanimous affirmative vote of the voting Members of the professional limited liability company.
