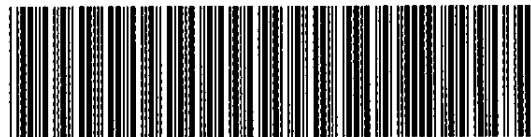

The Articles of Organization of **ROSEN SWITKES P.L.**, a Florida professional limited liability company (the "Corporation") originally filed with the Department of State of the State of Florida on June 24, 2002, are hereby amended pursuant to the Florida Professional Service Corporation and Limited Liability Company Act (the "Act") as follows:

ARTICLE 1

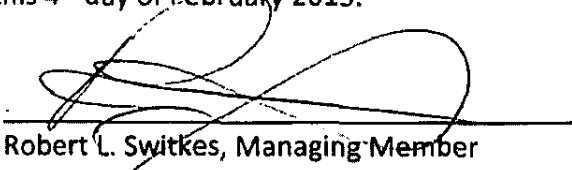
Name & Purpose. The name of the professional limited liability company is **ROSEN & SWITKES P.L.**, which is formed for the purpose of the practice of law and operation of a law firm.

ARTICLE 8
