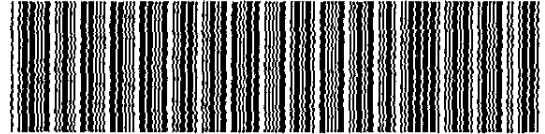

ARTICLE I

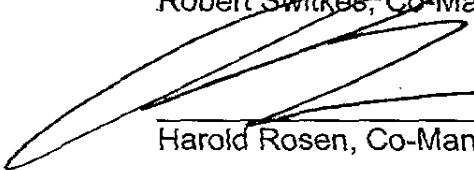
