ARTICLES OF ORGANIZATION

FOR

CCV HOMES, LLC

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned as organizers and Members of CCV HOMES, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes adopt the following, Articles of Organization:

ARTICLE I - NAME
