**ARTICLES OF ORGANIZATION
OF
STARWEB SYSTEMS, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is Starweb Systems, LLC (the "Company").

ARTICLE II. PERIOD OF DURATION

The duration of the Company shall be perpetual, subject to termination in accordance with the Company's operating agreement or by the unanimous written agreement of the Members.

ARTICLE III. ADDRESS

ARTICLE IV. REGISTERED OFFICE AND AGENT

ARTICLE VII. OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company.




