CLEDENNING ENTERPRISES, L.L.C., (Document Number is L02000016398) a limited liability company organized and existing under the laws of State of Florida (the "Company"), whose original Articles of Organization of the Company were filed and made effective on **June 28, 2002**; the Amended and Restated Articles of Organization were filed and made effective **July 1, 2016**, and in order to amend and restate its Articles of Organization in accordance with the requirements of Section 605.0202, Florida Statutes, does hereby submit these Amended and Restated Articles of Organization.

Article I – Name

The name of this limited liability company (the "Company") shall be:

Article II – Principal Office and Mailing Address

Article IV – Operating Agreement

Except for rights that are specifically reserved to the members in the Operating Agreement or these Articles, management of the Company shall be vested in its manager(s). Accordingly, the Company shall be a manager-managed company. Initially the Company shall have two managers. The number of managers of the Company and the number and titles of officers of the Company, as well as their respective rights and duties, may be established and changed, at any time and from time to time, subject to applicable law and the terms and provisions of the Company's Operating Agreement. Article VI – Amendment of Articles of Organization




