ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be Leonard-Kreegel, LLC, and the mailing address and street address of its principal office shall be 3855 San Lorenzo Drive, Punta Gorda, Florida 33950, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

INITIAL REGISTERED OFFICE AND REGISTERED AGENT



