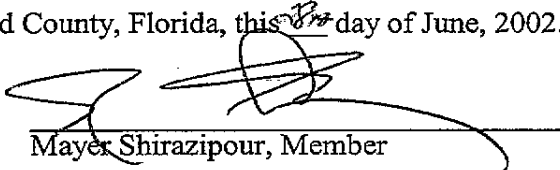
ARTICLE I

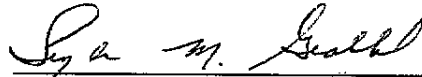

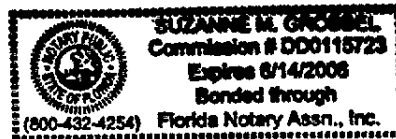

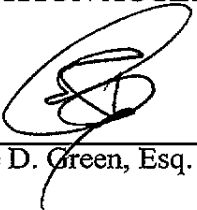
