


**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

**ARTICLE V -- MANAGEMENT**



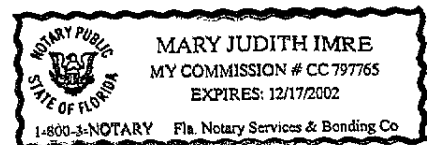


