# ARTICLES OF ORGANIZATION OF CABINETS DIRECT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be CABINETS DIRECT, LLC ("company").

#### ARTICLE II - ADDRESS
