ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be ST. JOHN'S EQUIPMENT CO., LLC, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 7320 State Road 13 North, St. Augustine, Florida 32092 and the mailing address shall be PMB-264, 445 State Road 13 North, Unit 26, Jacksonville, Florida 32259-3838.
