## ARTICLES OF ORGANIZATION FOR CREATIVE FINANCIAL SOLUTIONS, LLC

ARTICLE 1 - Name. The name of the limited liability company shall be Creative Financial Solutions, LLC.

ARTICLE 2 - Address of Principal Office. The mailing address and principal office of the limited liability company shall be 4044 West Lake Mary Boulevard, Unit 104-404, Orlando, Florida, 32746-2012.

ARTICLE 3 - Registered Office and Registered Agent. The name and the Florida street address of the initial registered agent is Philip K. Calandrino, P.A., 7232 Sand Lake Road, Suite 201, Orlando, Florida 32819.

ARTICLE 4 - Management. One or more managers shall manage the limited liability company. Therefore, it is a manager-managed company.
