**ARTICLES OF ORGANIZATION  
FOR

**ARTICLE 1 – Name.** The name of the limited liability company shall be Creative Financial Solutions, LLC.

**ARTICLE 2 – Address of Principal Office.** The mailing address and principal office of the limited liability company shall be 4044 West Lake Mary Boulevard, Unit 104-404, Orlando, Florida, 32746-2012.

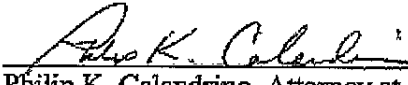

**ARTICLE 4 – Management.** One or more managers shall manage the limited liability company. Therefore, it is a manager-managed company.
