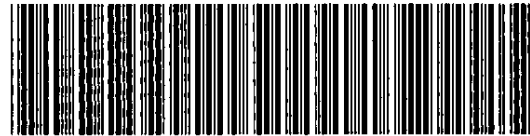

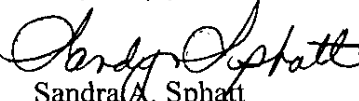

ARTICLES OF ORGANIZATION
OF

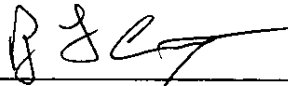
ARTICLE VI
