TO
ARTICLES OF ORGANIZATION OF
XCENDA, L.L.C.

FIRST: The Articles of Organization for Florida Health Strategies, L.L.C. were filed on July 5, 2002, and assigned document number L02000016954. On July 30, 2002, Florida Health Strategies, L.L.C. amended its Articles of Organization to change its name to Applied Health Outcomes, L.L.C. On July 5, 2006, Applied Health Outcomes, L.L.C. amended its Articles of Organization to change its name to Xcenda, L.L.C.

SECOND: The following amendments to the Articles of Organization were adopted by the Limited Liability Company:

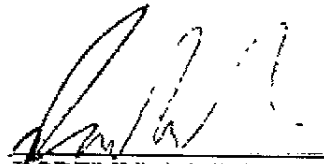
