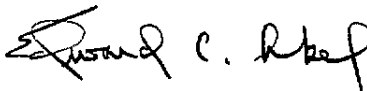

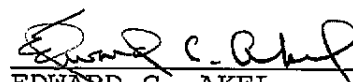
ARTICLE IV

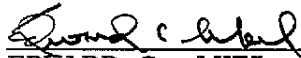
