### INDEMNIFICATION

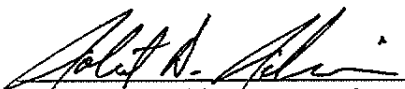

This Limited Liability Company shall exist in perpetuity unless legally dissolved as provided under the laws of the State of Florida

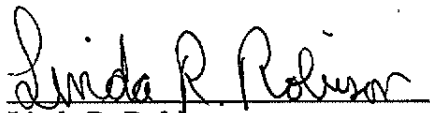
