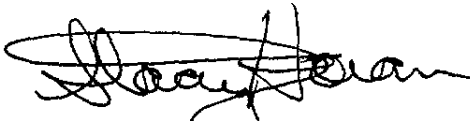

**ARTICLE II - DATE OF DISSOLUTION**

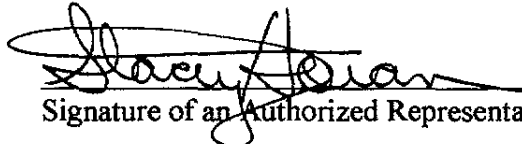
This dissolution of the Company shall be effective on and as of the date of filing of these Articles of Dissolution with the Secretary of State of the State of Florida.
