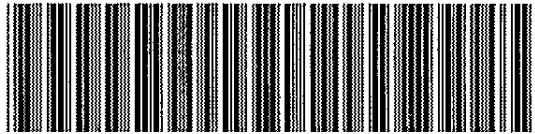


Article I of the Articles of Organization of the Company shall be amended in its entirety to read as follows:
