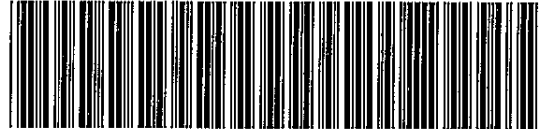

The name of the Limited Liability Company is **PHG - Hammock, LLC**.


**ARTICLE III**
