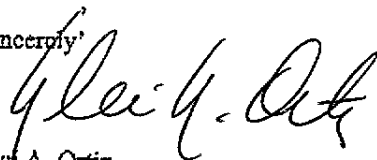

ARTICLES OF ORGANIZATION FOR  
ALEI AND ANI'S SHABBY SHAK, LLC.

The undersigned hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit. We further declare that the following Articles of Organization shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE I  
NAME

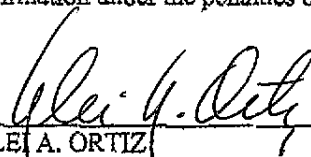
ARTICLE VII

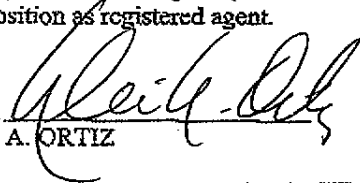
