Articles of Organization
of The Alliance Group of Tampa Bay, LLC.

Preamble

The Limited Liability Company described herein is a hybrid of a partnership and a corporation authorized by Chapter 608, Florida Statutes.

This company will be a manager-managed company governed by an operating agreement governing the affairs of this limited liability company and the conduct of its business as authorized by section 608.422, Florida Statutes.

Article I. Name

The name of the limited liability company is The Alliance Group of Tampa Bay, LLC.

Article II. Duration

The company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the company, then in accordance with the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

Article III. Purpose or Purposes

The purpose for which the company is organized is the transaction of any lawful business for which limited liability companies may be organized under the State of Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

Article VI. Company Management

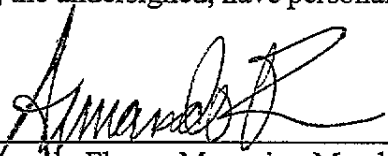
The company is to be a manager-managed company. It will be managed by Armflo, LLC., 4015 Carrollwood Village Dr., Tampa, FL 33626.

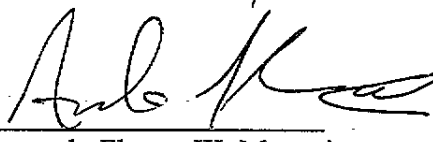
