ARTICLE VIII AMENDMENTS

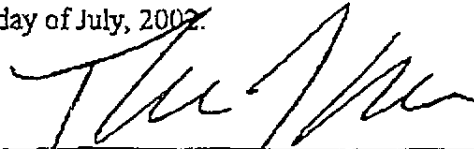

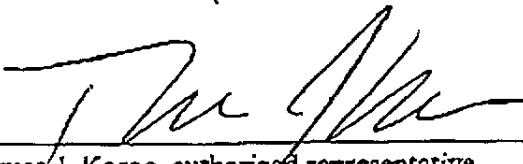
