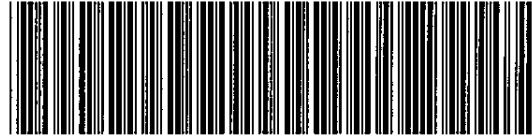

5. These Articles of Amendment shall be effective upon the filing with the Florida Department of State.


