ARTICLES OF ORGANIZATION
FOR LIMITED LIABILITY COMPANY

ARTICLE I

Name

The name of the Limited Liability Company is:

ARTICLE II

Address

The mailing address and street address of the principal office of the Limited Liability Company is 2831 Exchange Port, Suite A, West Palm Beach, Florida 33409.

ARTICLE III

Duration

The period of duration for the Limited Liability Company shall be for ninety nine (99) years.

ARTICLE IV

Management

ARTICLE V

Admission of Additional Members

Members shall have the right to admit additional members according to the following terms and conditions: All members are required to vote on whether to admit any additional members. Members may conduct these matters telephonically, where a roll call will be taken for record keeping purposes. Each member's vote shall be weighted in proportion to the member's ownership percentage in accordance with Article IV.

ARTICLE VI

Members Rights to Continue Business

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the member or his estate must proffer his ownership to the other member(s) with an asking price as determined by the operating agreement. The remaining members will then have the right to either (i) accept the asking price and purchase the outgoing

members ownership, or (ii) proffer their ownership to the outgoing member for the same price, prorated based on their ownership percentage(s) at the time of the occurrence.






