The mailing address and street address of the principal office of the Company is: 1631 N.E. 5<sup>th</sup> Street, Fort Lauderdale, Florida 33301.


ARTICLE III - Registered Agent

These Articles of Organization are hereby executed by the undersigned Member of the Company.


