## ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

### **ARTICLE I-Name and Principal Place of Business**

The name of the limited liability company shall be **FORGOTTEN COAST COMMUNICATIONS**, **LLC** (hereinafter the "Company"). The principal place of business and mailing address of the Company shall be 2808 Remington Green Circle N., Suite 200, Tallahassee, Florida 32308.
