# ARTICLES OF ORGANIZATION OF NIKEEH HOLDINGS, LC

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, adopts the following Articles of Organization.

#### **ARTICLE I**

#### NAME

The name of the limited liability company is Nikeeh Holdings, LC.

### ARTICLE II

#### **ADDRESS**

The principal office and mailing address of the limited liability company shall be 1155 Nicholson Raod, Jacksonville, Florida 32207.

#### ARTICLE III

#### **DURATION**
