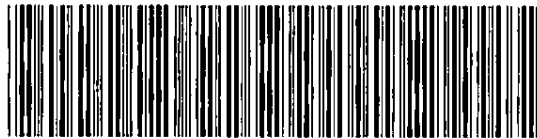

STATEMENT OF AUTHORITY

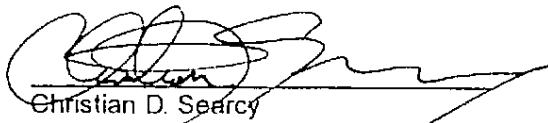
