A. The name of this Limited Liability: Company is

CINOS ENTERPRISES OF FLORIDA, L.L.C., (the "Company").

- B. The Articles of Organization of the company were filed with the Florida Secretary of State on July 12, 2002.
- C. The Articles of Organization of the company are amended pursuant to a resolution adopted by the members in conformity with the companies Regulations as follows:
