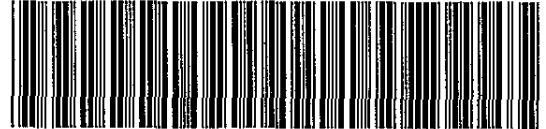




**ARTICLES OF DISSOLUTION

3076 NEW YORK, L.L.C.**


