The management of the limited liability company is reserved to its president; N. Maria Menendez.

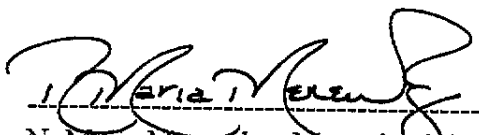
ARTICLE IV
