MANAGEMENT**





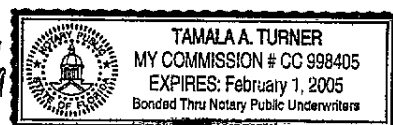
