ARTICLE I Name

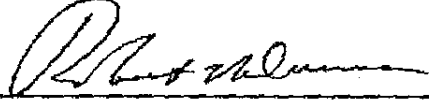
The name of the Company is: **FRANKLIN COMMUNICATIONS, LLC**
