ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company the Florida Limited Liability Company Act, F.S. Chapter 608 (the "Act" the following Articles of Organization. under the Florida Limited Liability Company Act, F.S. Chapter 608 (the "Act" hereby make, acknowledge and file the following Articles of Organization.

#### ARTICLE I - NAME
