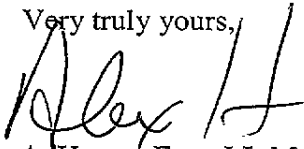

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make, acknowledge, and file the foregoing Articles of Organization.

ARTICLE I: NAME

The name of the limited liability company shall be **JOHN DOE ENTERTAINMENT, LLC** (the "Limited Liability Company").

ARTICLE II: ADDRESS

The initial principal place of business and mailing address for the Limited Liability Company shall be 286 Westward Drive, Miami Springs, FL 33166.

ARTICLE III: DURATION

The Limited Liability Company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The Limited Liability Company's existence shall be perpetual unless the Limited Liability Company is earlier dissolved as provided in these articles of organization or the regulations of the Limited Liability Company.

ARTICLE IV: PURPOSE

The purpose for which the Limited Liability Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Limited Liability Company shall have all of the powers vested in a Limited Liability Company organized and existing by virtue of such laws.

ARTICLE IX: REGULATIONS

The member(s) shall have the power to adopt, alter, amend or repeal regulations of the Limited Liability Company containing provisions for the regulation and management of the affairs of the business of the Limited Liability Company.

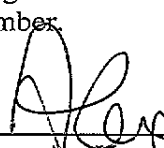

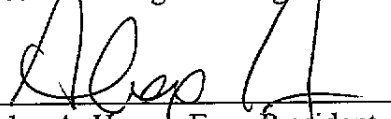
