**ARTICLES OF ORGANIZATION  
OF

Registered Agent and Office

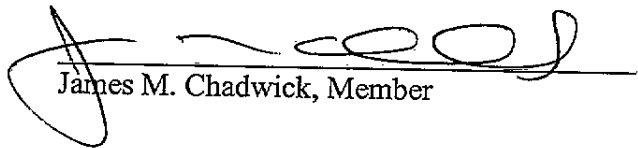
The initial registered agent for this Company shall be James M. Chadwick, Esq., Row

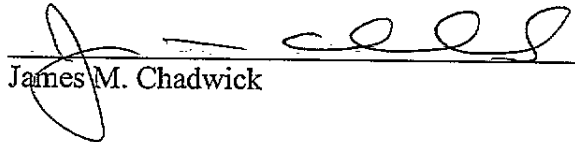
