The name of the Limited Liability Company (the "Company") is Main Street Palm Beach, LLC.

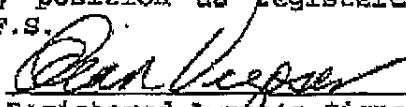
ARTICLE IIAddress
