**ARTICLES OF ORGANIZATION OF
NOHO GROUP, LLC**

The undersigned, being authorized to execute and file these Articles pursuant to Chapter 608, Florida Statutes, hereby certifies that:

ARTICLE I — Name

The name of the Limited Liability Company is NoHo Group, LLC.

ARTICLE II — Address
