# ARTICLES OF ORGANIZATION OF CLERMONT ASSOCIATES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

### ARTICLE I --- NAME

The name of the limited liability company shall be Clermont Associates, LLC (the "Company").
