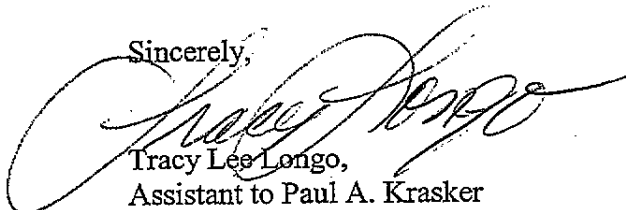

**ARTICLES OF ORGANIZATION
OF
MANA INVESTMENTS, LLC**

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

ARTICLE I

ARTICLE VI

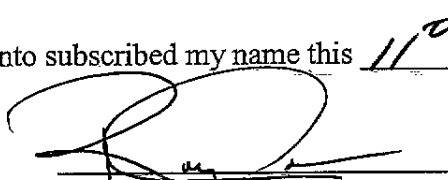
The power to adapt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the vote of its Manager.

Except as otherwise provided by law, no debt in excess of \$5,000.00 shall be contracted nor liability incurred by or on behalf of this Company except by its Manager.

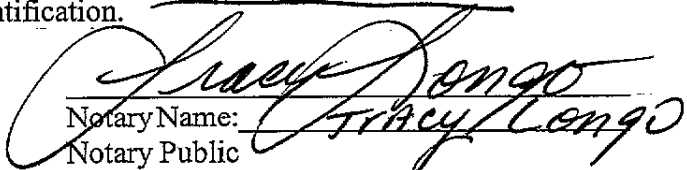
