Articles of Organization

of

SUNDERCO, LLC

ARTICLE I

Name and Duration

The name of this Limited Liability Company is SUNDERCO, LLC (hereinafter referred to as the "Company"). The duration of the Company shall be perpetual.

ARTICLE II

Principal Office
