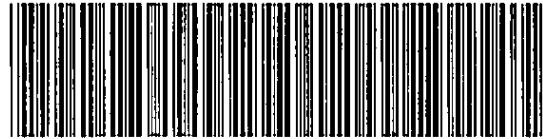

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF

Pursuant to Chapter 12 of Title 13.1 of the Code of Virginia the undersigned states as follows:
