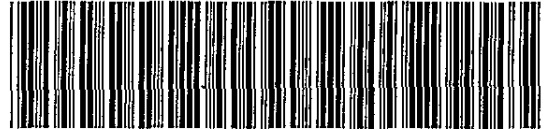


FIRST: The Articles of Organization for the limited liability company now known as 205 South MacDill, LLC were filed on July 22, 2002 and assigned document number L02000018483.


